MEMORANDUM OF ASSOCIATION

- 1. The name of the society shall be the "Bethany Christian Institute" Churachandpur
- 2. The office of the society is situated at:- Family Land, Bijang, Churachandpur 795128, P.O Box No. -23, Manipur, India
- 3. (a) area of operation; within Manipur at present and the North east India in the long run as the Lord leads and necessity demands it will operate in the other parts of India and aboard.
 - (b) Covers and includes All sections of people and human beings of irrespective creed, caste and colours.

The Bethany Christian is an institute is a voluntary, non-profit making, charitable social service organization established to promote educations amongst educationally backward section of society. The aims and object for which this foundation is established are:-

- a) To remove educational backwardness, and create awareness about the national ideas of JUSTICE, LIBERTY, EQUALITY AND FRATERNITY AND DEMOCRACY, SECULARISM AND SOCIALISM;
- To formulate and implement education schemes and plans for the national ideals of JUSTICE, LIBERTY, EQUALITY AND FRATERNITY AND DEMOCRACY, SECULARISM and SOCIALISM;
- c) To promote research and encourage other efforts designed to mould educational policies of the Government for the benefit of the educationally backward communities;
- d) To establish residential schools especially for girls and tribals in order to provide modern education to educationally backward communities of NE-India, preferably in or around, urban, semi urban and rural areas;
- e) To assist and support, and evaluate from time to time the implementation of the National Policy on Education and the Right to Education Acts in an effective manner, especially in regards to its Provisions relating to the educationally backwards tribal and rural communities;
- f) To provide financial and other aid or consultancy service to institutions / organization engaged in the promotions of education among the educationally backward communities;
- g) To function as a data bank on education and to establish information and counselling centres;
- h) To undertake preparation and publication of materials including journals and other periodicals and preparation and dissemination of material for mass media;
- i) To collaborate with and other Societies/organizations pursuing the objective similar to those of the Bethany Christian Institute;

- i) To collaborate with and other Societies/organizations pursuing the objective similar to those of the Bethany Christian Institute;
- j) To open, run and assist Libraries and Book Banks;
- k) To create awareness about the problems of the weaker sections especially the educationally backward tribal communities and to give appropriate advice to policy makers and the Government;
- 1) To establish educational institutions, technical, vocational, computer centres, engineering colleges and physical education, sports centres.
- m) To established hostels for boys and girls
- n) To organize educational seminars, lectures, symposium, workshops, competitions and quizzes
- To take up higher education and spiritual development
- p) To undertake all such activities as are not specifically mentioned in the aims and objects listed above, but which promote these objectives.
- 4. In furtherance of and consistently with these objects, it may;
 - a) Raise funds from individuals and institutions within and outside the country;
 - b) Receive grants-in-aid from Government and assistance from the institutions;
 - c) Purchase, take on loans, or exchange, hire, accept as gift or otherwise require any movable or immovable property, or rights therein of privileges attaching thereto which may be necessary or convenient for its objects.
 - d) Sell, lease, mortgage, let on hire, exchange, or otherwise dispose off all or any portion of its property, rights, assets or liabilities to any other Society, Trust, person or persons;
 - e) Use print and electronic media to disseminate necessary information;
 - f) Receive moneys due to it and invest its funds and moneys in securities or property or in any other form and to operate its accounts with any scheduled bank or approved financial institution upon such terms and conditions and in such manner as may be determined from time to time.
 - g) Borrow or raise money, if necessary by mortgaging or charging the whole or any part of its property assets or rights, on such terms and conditions and in such manner as may be determined from time to time.
 - h) Do all such other acts whether incidental to the powers aforesaid or not, as may be required to further its objects
